

**Resolution 20-2014**

**A RESOLUTION TO RATIFY THE REALIGNMENT OF MONIES WITHIN THE SEWER FUND FROM THE CAPITAL OUTLAY FUND 5201-549-590 AND TRANSFER IT TO THE OTHER – PERSONAL SERVICES PLANT OPERATOR FUND 5201-549-190-1008 AND DECLARE IT AN EMERGENCY.**

WHEREAS, Council is authorized to transfer funds within the Sewer Fund of the Village of Commercial Point; and

WHEREAS, the personal services for the Plant Operator were higher than anticipated; and

WHEREAS, the Capital Outlay expenditures were lower than anticipated; and

WHEREAS, on November 24, 2014, the Village Fiscal Officer transferred funds to ensure payment of the personal services for the Plant Operator that were due; and

WHEREAS, Council hereby ratifies the actions of the Village Fiscal Officer.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF COMMERCIAL POINT, COUNTY OF PICKAWAY, STATE OF OHIO, A MAJORITY OF ITS MEMBERS ELECTED THERETO CONCURRING THAT:

Section 1. Council hereby ratifies the action taken by the Village Fiscal Officer on November 24, 2014 as further set forth in Section 2 below.

Section 2. Monies in the amount of Four Thousand Dollars (\$4,000.00) shall hereby be transferred within the Sewer Fund of the Village of Commercial Point from Account Number 5201-549-590, Capital Outlay, to Account Number 5201-549-190-1008, Other – Personal Services Plant Operator Fund, for the payment of the personal services that are due.

Section 3. For the reasons set forth above, this Resolution is hereby declared an emergency and shall be in full force and effect upon passage.


