

RESOLUTION 11-2015

A RESOLUTION AUTHORIZING AND DIRECTING THE VILLAGE ADMINISTRATOR AND/OR MAYOR OF THE VILLAGE OF COMMERCIAL POINT TO ENTER INTO A SECOND CONTRACT REGARDING LAW ENFORCEMENT SERVICES ON BEHALF OF THE VILLAGE OF COMMERCIAL POINT WITH THE PICKAWAY COUNTY SHERIFF'S FROM JUNE 2, 2015 – AUGUST 29, 2015 AND DECLARING IT AN EMERGENCY.

WHEREAS, the Village Council has determined a need for additional law enforcement services to safeguard life, health, property, safety and public welfare; and

WHEREAS, the Village has one employed officers and is in need of additional law enforcement; and

WHEREAS, the Village Council hereby finds and determines that it is in the best interest of the residents of the Village to have additional law enforcement; and

WHEREAS, the Village Administrator and/or Mayor desires to contract with the Pickaway County Sheriff's Department on behalf of the Village for law enforcement services.

NOW THEREFORE, be it resolved by the Council of the Village of Commercial Point, Pickaway County, Ohio, a majority or more of the members elected thereto concurring that:

SECTION 1: The Council of the Village of Commercial Point hereby authorizes and directs the Village Administrator and/or Mayor to enter into a contract with the Pickaway County Sheriff's Department. The contract will be from June 2, 2015 – August 29, 2015.

SECTION 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3: That this resolution is hereby declared to be an emergency measure and shall take effect and be in force immediately from and after its passage. The Village has only one employed officers and additional hours are needed to safeguard life, health, property and public welfare.



2015 LAW ENFORCEMENT CONTRACT #2
VILLAGE OF COMMERCIAL POINT

This Agreement is made this 2nd day of June 2015, between the SHERIFF OF PICKAWAY COUNTY, OHIO hereinafter referred to as "SHERIFF", and the VILLAGE OF COMMERCIAL POINT, Pickaway County, Ohio, hereinafter referred to as the "VILLAGE".

WITNESSETH

WHEREAS, the VILLAGE is desirous of acquiring additional police protection for the property and residents of the VILLAGE OF COMMERCIAL POINT, Pickaway County, Ohio, through the Office of the Pickaway County Sheriff; and

WHEREAS, the SHERIFF is willing to provide such police services as are set forth below and having determined that the cost of providing such services have been ascertained to be an amount not less than the payments required hereunder;

NOW, THEREFORE, pursuant to the terms of Revised Code Section 311.29 and in consideration of the mutual covenants expressed herein, it is agreed as follows:


1. The SHERIFF agrees to provide a uniformed Deputy Sheriff(s) for (390) man hours from June 1, 2015 through August 29, 2015, to keep the peace, to protect the property and to perform other necessary police functions in said VILLAGE; and the SHERIFF further agrees to make available to the aforesaid Deputy Sheriff(s), all training programs and other regular facilities of the Sheriff's Office. Additionally, the said VILLAGE will be furnished with one equipped patrol car, marked in accordance with Ohio Revised Section 311.28, and all necessary fuel and maintenance for said patrol car.
2. The VILLAGE agrees to pay the SHERIFF the sum of \$11,750.00 payable in two equal installments or at such times as may be mutually agreed upon, to the Treasurer of Pickaway County, Ohio, to a special funds to be known as the "SHERIFF'S POLICE REVOLVING FUND". Additionally, the said Village will furnish equipment and office space (as a substation for contract and district patrol cars) to the SHERIFF that was previously utilized by the Village Police Department.
3. The County, its officers and employees, including but not limited to, the SHERIFF and his employees, shall not be deemed to assume any liability for the intentional or negligent acts or omissions of the VILLAGE, or any officer, agency or employee thereof, and said VILLAGE agrees to hold harmless, indemnify and defend the County and the SHERIFF, and their officers and employees, from any and all claims for damages arising there from. The VILLAGE agrees to hold harmless, indemnify and defend the County and the SHERIFF, their officers and employees from any and all claims for damages resulting from the enforcement of any Ordinance of the VILLAGE, excepting claims arising from the alleged personal misconduct or negligence of a Sheriff's Deputy or employee.
4. It is understood and agreed by the parties that no Deputy of other employee of the SHERIFF, shall be deemed an employee of the VILLAGE, except as otherwise stated herein. It is further mutually agreed between the parties that the duties of the aforesaid Deputy Sheriff(s) will be determined from time to time by the best judgement of the SHERIFF and VILLAGE including but not limited to, normal police duties, serving of Court papers, duties in cooperation with VILLAGE functions, and further that the VILLAGE specifically acknowledges that the operation of the agreement and the

responsibilities of the SHERIFF hereunder are directly contingent upon the availability of manpower and equipment to perform services requested and needed by the VILLAGE; and further that in the event that such manpower and equipment is not available due to emergencies and/or other assignments necessary under law, such VILLAGE specifically waives liability of the SHERIFF hereunder.

5. A report of activity is to be made available at monthly Council Meetings and funds for the same are to be payable at that time.
6. The SHERIFF reserves the right to use the aforesaid Deputy Sheriff(s) in an emergency or emergencies as he sees fit.
7. This contract shall be for thirteen weeks, and terminates on the 29st day of August, 2015.

Termination of the Agreement prior to the above written date requires a thirty (30) day written notice by either party.




