

**AN ORDINANCE ACCEPTING THE BID OF RUMPKE OF OHIO, INC. FOR THE VILLAGE OF COMMERCIAL POINT REFUSE COLLECTION AND CURBSIDE RECYCLING PROGRAMS STARTING JANUARY 1, 2019, AND AUTHORIZING AND DIRECTING THE VILLAGE ADMINISTRATOR AND/OR MAYOR OF THE VILLAGE OF COMMERCIAL POINT TO ENTER INTO A CONTRACT WITH SAME, AND DECLARING IT AN EMERGENCY.**

WHEREAS, advertisement for bids for refuse and possible curbside recycling collection services for a three year contract starting January 1, 2019 occurred; and

WHEREAS, said bids were publically open and read on June 21, 2018; and,

WHEREAS, the lowest and best bid was received from Rumpke of Ohio, Inc.; and,

WHEREAS, Rumpke of Ohio, Inc is a responsible bidder capable and qualified to perform the work, and that its bid was in compliance with all bid, contract and legal requirements.

WHEREAS, Curbside recycling for all customers will be required.

**NOW THEREFORE BE IT ORDAINED** by the Council of the Village of Commercial Point, Pickaway County, State of Ohio:

**SECTION 1:** The bid of Rumpke of Ohio Inc. is hereby accepted.

**SECTION 2:** The Village Mayor and/or Village Administrator are hereby authorized to enter into a contract with Rumpke of Ohio Inc. in accordance with the specifications of the bid and contract documents.

**SECTION 3:** That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

**SECTION 4:** That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of public peace, health, safety and welfare of the inhabitants of the Village of Commercial Point because timely award is needed to ensure refuse collection is uninterrupted. Wherefore, this Ordinance shall take effect and be in force from and immediately upon passage.


