

ORDINANCE 2020-08

AN ORDINANCE ESTABLISHING THE POSITION OF PART-TIME CAPTAIN WITHIN THE VILLAGE OF COMMERCIAL POINT POLICE DEPARTMENT.

WHEREAS, Ohio Revised Code Section 737.16 authorizes the mayor of a village to appoint all police officers within the village police department when such positions are provided for by the legislative authority of the village; and

WHEREAS, the Mayor of the Village of Commercial Point has recommended to Village Council that the position of one (1) part-time Captain position be established within the Village of Commercial Point Police Department; and

WHEREAS, the duties of police captain are currently fulfilled by a member of the Village Auxiliary Police Unit under Ohio Revised Code Section 737.161 and Village of Commercial Point Codified Ordinances Section 236.04; and

WHEREAS, the provision of a compensated, part-time Captain position within the Village of Commercial Point Police Department will positively contribute to the overall operations of the Police Department.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF COMMERCIAL POINT, OHIO THAT:

SECTION 1. The position of Captain is hereby established in the Village of Commercial Point Police Department.

SECTION 2. The position of Captain shall be part-time and compensated at no more than twenty (20) hours per week.

SECTION 3. The Mayor of the Village of Commercial Point is hereby authorized to appoint an individual to the position of part-time Captain subject to Ohio Revised Code Sections 737.16 and 737.17.

SECTION 4. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any other committees that result in such formal action were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 5. This Ordinance shall take effect and be in force from and after the earliest date allowed by law.




