

ORDINANCE 2020-11

**AN ORDINANCE AUTHORIZING THE MAYOR OF THE VILLAGE OF COMMERCIAL POINT TO ASSIGN THE VILLAGE ENGINEER ADDITIONAL HOURS PER MONTH AS NEEDED.**

**WHEREAS**, the Village Council is authorized to provide for the compensation of Village employees under Ohio Revised Code Section 731.13; and

**WHEREAS**, Council has authorized the Village Engineer to work a maximum of sixty (60) hours per month at a rate of thirty dollars (\$30.00) per hour; and

**WHEREAS**, the Village of Commercial Point has, in recent years, experienced substantial residential and commercial development requiring the utilization of the Village Engineer's knowledge, time, and expertise; and

**WHEREAS**, the Village of Commercial Point anticipates continued development in years to come that will, at certain times, require the Engineer's knowledge, time, and expertise in excess of sixty (60) hours per month.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF COMMERCIAL POINT, OHIO THAT:**

**Section 1.** The Mayor of the Village of Commercial Point is hereby authorized to assign the Village Engineer up to fifteen (15) additional hours per month beyond the Engineer's maximum allotted sixty (60) hours per month at a rate of compensation of thirty dollars (\$30.00) per hour if, in the Mayor's discretion and subject to appropriation of moneys by Council, the Mayor determines additional work by the Engineer is necessary.

**Section 2.** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any other committees that result in such formal action were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

**Section 3.** This Ordinance shall take effect and be in force from and after the earliest date allowed by law.




