

ORDINANCE 2022-13

AN ORDINANCE WAIVING THE RESIDENCY REQUIREMENT FOR JOHN R. GROSSE, VILLAGE ADMINISTRATOR, PURSUANT TO OHIO REVISED CODE SECTION 735.271.

WHEREAS, Ohio Revised Code Section 735.271 provides that the legislative authority of a statutory village may provide for the position of Village Administrator; and

WHEREAS, the Village of Commercial Point Village Council has established the position of Village Administrator; and

WHEREAS, Ohio Revised Code Section 735.271 also provides that the Village Administrator shall become a resident of the Village within six months after his appointment by the mayor and confirmation by the legislative authority of the Village, unless his residence outside the Village is approved by ordinance; and

WHEREAS, John R. Grosse was appointed Village Administrator by the Mayor and confirmed by the Village Council on January 6, 2022; and

WHEREAS, Village Council is required to waive the residency requirement under Ohio Revised Code Section 735.271 for Village Administrator Grosse, who resides outside the corporate limits of the Village of Commercial Point, no later than July 6, 2022; and

WHEREAS, Village Council wishes to waive the residency requirement for Village Administrator Grosse during his tenure as Village Administrator.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF COMMERCIAL POINT, PICKAWAY COUNTY, OHIO THAT:

SECTION 1. Waiver of Residency Requirement for Village Administrator John R. Grosse. Village Council hereby waives the residency requirement under Ohio Revised Code Section 735.271 for Village Administrator John R. Grosse during his tenure as Village Administrator for the Village of Commercial Point.

SECTION 2. Open Meetings Certification. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any other committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 3. Effective Date. This Ordinance shall take effect and be in force from the earliest date allowed by law.
