

Resolution 24-2018

A RESOLUTION AUTHORIZING AND DIRECTING THE VILLAGE ADMINISTRATOR OF THE VILLAGE OF COMMERCIAL POINT TO ENTER INTO AN ANNUAL CONTRACT BEGINNING DECEMBER 1, 2018 to DECEMBER 31, 2019 WITH THE SCIOTO TOWNSHIP TRUSTEES FOR SNOW REMOVAL ON THE VILLAGE STREETS.

WHEREAS, pursuant to O.R.C. §731.141 the Village Administrator is authorized to enter into contracts on behalf of the Village; and

WHEREAS, Council has determined that it desires to revise the existing contract with the Scioto Township Trustees for snow and ice removal for 2018-2019 as the document attached hereto as Exhibit "A".

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF COMMERCIAL POINT, COUNTY OF PICKAWAY, STATE OF OHIO, TWO THIRDS OF ITS MEMBERS ELECTED THERETO CONCURRING THAT:

Section 1. The Village Administrator is hereby authorized and directed to enter into an annual contract for December 1, 2018 – December 31, 2019 with the Scioto Township Trustees for snow and ice removal services, in substantially the same format and content, as the document attached hereto as Exhibit "A" and incorporated herein by reference, on behalf of the Village of Commercial Point.

Section 2. It is hereby found and determined that all formal actions of the Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision making bodies of the Village of Commercial Point which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

## SNOW REMOVAL AGREEMENT

1. The Village of Commercial Point hereby contracts with the Scioto Township Trustees for snow removal beginning on December 1, 2018 to December 31, 2019, at a rate of One Hundred Fifty Dollars (\$150.00) per hour plus the true cost of supplemental materials.
2. This is a binding and continuing contract between both parties. Either party wishing to terminate this contract must do so in writing by October 1<sup>st</sup>, but no earlier than May 1<sup>st</sup> of each calendar year.
3. The Village of Commercial Point agrees to trim any tree limbs that the Scioto Township Trustees deem to be too low for township trucks to operate under.
4. The Mayor or Village Administrator shall be the contact person for the Village. The first contact person for the Township will be John Maynard at (614) 832-9246; back up contacts for the Township will be Ron Jahn at (614) 348-1421 and Ralph Wolfe at (614) 218-4900.
5. The order of snow removal shall be Township roads first and then the Village of Commercial Point streets.
6. Neither Scioto Township as a whole, nor Scioto Township Trustees individually, shall be responsible for any damage to the streets or curbs in the Village of Commercial Point caused by snow removal pursuant to this contract.
