

RESOLUTION 03-2019

A RESOLUTION TO RATIFY THE REALIGNMENT OF MONIES WITHIN THE SEWER FUND FROM THE CAPITAL OUTLAY ACCOUNT 5201-549-590 AND TRANSFER SAID MONIES TO THE OTHER PERSONAL SERVICES (SUPERINTENDENT) ACCOUNT 5201-549-190-1009.

WHEREAS, Council is authorized to create, appropriate, and transfer funds within the Sewer Fund of the Village of Commercial Point; and

WHEREAS, monies appropriated to the Capital Outlay account were more than needed; and

WHEREAS, monies appropriated to the Other Personal Services (Superintendent) account were less than needed; and

WHEREAS, on December 31, 2018 the Fiscal Officer transferred monies within the Sewer Fund to make the final payroll payment for the year.

WHEREAS, the Council of the Village of Commercial Point desires to ratify the action of the Village Fiscal Officer.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF COMMERCIAL POINT, COUNTY OF PICKAWAY, STATE OF OHIO, A MAJORITY OF ITS MEMBERS ELECTED THERETO CONCURRING THAT:

Section 1. Council hereby ratifies the action taken by the Village Fiscal Officer on December 31, 2018 as further set forth in Section 2 below.

Section 2. Monies in the amount of Seven Hundred Sixteen dollars and Fifty-One cents (\$716.51) shall hereby be transferred within the Sewer Fund of the Village of Commercial Point from Account Number 5201-549-590 Capital Outlay Account to Account Number 5201-549-190-1009 Other Personal Services Account.

Section 3. It is hereby found and determined that all formal actions of the Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision making bodies of the Village of Commercial Point which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 4. This Resolution shall take effect and be in force from and after the earliest date allowed by law.






