

**RESOLUTION 33-2020**

**A RESOLUTION TO APPROPRIATE THE MONEY RECEIVED FROM PICKAWAY COUNTY FOR THE LOCAL CORONAVIRUS RELIEF FUND WITHIN THE 2020 PERMANENT BUDGET AND DECLARE AN EMERGENCY.**

**WHEREAS**, Council is authorized to appropriate funds for the Village of Commercial Point; and

**WHEREAS**, Council requested its share of funds from the Pickaway County Coronavirus Relief Distribution Fund by passage of Resolution 30-2020 on September 14, 2020; and

**WHEREAS**, Council established a Local Coronavirus Relief Fund by passage of Resolution 31-2020 on September 21, 2020; and

**WHEREAS**, the Village received \$ 23,006.37 on September 29, 2020 from Pickaway County from Rounds 1 & 2 of the CARES Act funds; and

**WHEREAS**, Council wishes to appropriate all of this money received within the 2020 permanent budget in accordance with the procedure described in Section 27 of H.B. 481 to the Village's Local Coronavirus Relief Fund.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF COMMERCIAL POINT, OHIO, BY A VOTE OF TWO-THIRDS OF THE MEMBERSHIP THEREOF, THAT:**

**Section 1.** Council hereby appropriates the \$23,006.37 received on September 29, 2020 from Pickaway County to the Village's Local Coronavirus Relief Fund within the 2020 permanent budget.

**Section 2.** Council hereby requests an amended certificate to allow for the expenditures within the Local Coronavirus Relief Fund in the 2020 permanent budget.

**Section 3.** This amended certificate is subject to the approval of the Pickaway County Budget Commission and the Pickaway County Auditor.

**Section 4.** This Ordinance is hereby declared to be an emergency measure and shall take effect and be in force immediately from and after its passage. This emergency measure is necessary for the health, safety and welfare of the residents of Commercial Point, as such emergency arises out of the need to appropriate said monies within the time restraints outlined by the State of Ohio.


