

RESOLUTION 01-2021

**A RESOLUTION TO RATIFY THE REALIGNMENT OF MONIES WITHIN THE SEWER FUND FROM THE OTHER-OTHER ACCOUNT 5201-549-690 AND TRANSFER SAID MONIES TO THE OTHER PERSONAL SERVICES (OPERATOR 1) ACCOUNT 5201-549-190-1008.**

**WHEREAS**, Council is authorized to create, appropriate, and transfer funds within the Sewer Fund of the Village of Commercial Point; and

**WHEREAS**, monies appropriated to the Other-Other account were more than needed; and

**WHEREAS**, monies appropriated to the Other Personal Services (Operator 1) account were less than needed; and

**WHEREAS**, on December 28, 2020 the Fiscal Officer transferred monies within the Sewer Fund to make the payment for the unused personal days for 2020 per the Employee Guidelines.

**WHEREAS**, the Council of the Village of Commercial Point desires to ratify the action of the Village Fiscal Officer.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF COMMERCIAL POINT, OHIO THAT:**

**Section 1.** Council hereby ratifies the action taken by the Village Fiscal Officer on December 28, 2020 as further set forth in Section 2 below.

**Section 2.** Monies in the amount of One Hundred Forty Dollars (\$140.00) shall hereby be transferred within the Sewer Fund of the Village of Commercial Point from Account Number 5201-549-690 Other-Other Account to Account Number 5201-549-190-1008 Other Personal Services Account (Operator 1).

**Section 3.** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council and that all deliberations of this Council and of any other committees that result in such formal action were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

**Section 4.** This Resolution shall take effect and be in force from and after the earliest date allowed by law.
