

RESOLUTION 08-2021

A RESOLUTION CONSENTING TO THE PROPOSED ANNEXATION OF +/- 5.300 ACRES FROM SCIOTO TOWNSHIP TO THE VILLAGE OF COMMERCIAL POINT, AND DECLARING AN EMERGENCY.

WHEREAS, a petition for an Expedited Type II annexation of +/- 5.300 acres from Scioto Township was filed with the Board of County Commissioners of Pickaway County, Ohio on or about February 18, 2021 by Donald Plank, attorney and agent for Petitioner Scioto Township Board of Trustees, John Maynard, Chair; and

WHEREAS, R.C. 709.023(D) provides that, within twenty-five days after the date that the petition is filed, the legislative authority of the municipal corporation to which annexation is proposed may adopt and file with the board of county commissioners an ordinance or resolution consenting or objecting to the proposed annexation; and

WHEREAS, an objection to a proposed annexation shall be based solely upon the petition's failure to meet the conditions specified in division (E) of R.C. 709.023; and

WHEREAS, the Village Council wishes to consent to the proposed annexation as described in the annexation petition filed by the agent of the Scioto Township Board of Trustees with the Pickaway County Board of Commissioners.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF COMMERCIAL POINT, OHIO THAT:

Section 1. The Village Council hereby consents to the proposed annexation, as described in the annexation petition in Exhibit A, which is attached hereto.

Section 2. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council and that all deliberations of this Council and of any other committees that result in such formal action were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

Section 3. Council declares this Resolution to be an emergency measure immediately necessary for the preservation of the public peace, health, and safety of the Village of Commercial Point and the further reason that this Resolution of Consent must be filed with the Pickaway County Board of Commissioners no later than March 15, 2021. Therefore, this Resolution shall take immediate effect upon passage.
