

RESOLUTION 10-2021

A RESOLUTION AUTHORIZING AND DIRECTING THE MAYOR AND CHIEF OF POLICE TO DONATE THE 2009 FORD CROWN VICTORIA CURRENTLY OWNED BY THE VILLAGE OF COMMERCIAL POINT TO THE EASTLAND-FAIRFIELD JOINT VOCATIONAL SCHOOL DISTRICT.

WHEREAS, the Village of Commercial Point is authorized to discard of municipal personal property that is not needed for public use, or is obsolete or unfit for the use for which it was acquired if the Village Council determines that the municipal personal property has no value pursuant to Ohio Revised Code Section 721.15(C);

WHEREAS, the Village of Commercial Point acquired a 2009 Ford Crown Victoria (VIN 2FAHP71V09X109046) from the Perry Township Board of Trustees, Franklin County, Ohio, on or about February 26, 2013 for three thousand eight hundred dollars and 00/100 cents (\$3,800.00); and

WHEREAS, the 2009 Ford Crown Victoria was put to use by the Village of Commercial Point Police Department for several years and for several thousands of miles; and

WHEREAS, the 2009 Ford Crown Victoria is no longer suitable for use by the Village of Commercial Point Police Department and is no longer needed for public use; and

WHEREAS, the 2009 Ford Crown Victoria no longer has any value; and

WHEREAS, the Village Council desires to donate the 2009 Ford Crown Victoria to the Eastland-Fairfield Joint Vocational School District for use in the School District's Criminal Justice program.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF COMMERCIAL POINT, OHIO THAT:

Section 1. The Village Council hereby finds that the 2009 Ford Crown Victoria (VIN 2FAHP71V09X109046) currently owned by the Village of Commercial Point, and more fully described in the Certificate of Title attached to this Resolution as Exhibit A and incorporated herein by reference ("2009 Ford Crown Victoria"), is not needed for public use by the Village and is obsolete for the purpose for which it was acquired.

Section 2. The Village Council hereby finds that the 2009 Ford Crown Victoria has no value.

Section 3. The Mayor and Chief of Police are hereby directed and authorized to take all necessary actions to effect the donation and transfer of title of the 2009 Ford Crown Victoria to the Eastland-Fairfield Joint Vocational School District.

Section 4. Prior to the donation described in Section 3 of this Resolution, the Police Chief shall remove all radio and electronic equipment owned by the Village of Commercial Point and used for law enforcement purposes within the vehicle, and remove all words and markings on the interior and exterior of the vehicle that indicate the vehicle's current ownership by or association with the Village of Commercial Point.

Section 5. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council and that all deliberations of this Council and of any other committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

Section 6. This Resolution shall take effect and be in force from and after the earliest date allowed by law.


