

RESOLUTION 03-2022

A RESOLUTION TO RATIFY THE REALIGNMENT OF MONIES WITHIN THE GENERAL FUND FROM THE TRANSFERS OUT ACCOUNT 1000-910-910 AND TRANSFER SAID MONIES TO THE OTHER PERSONAL SERVICES (PART-TIME OFFICER) ACCOUNT 1000-110-190-1013.

WHEREAS, Council is authorized to create, appropriate, and transfer funds within the General Fund of the Village of Commercial Point; and

WHEREAS, monies appropriated to the Transfers Out Account were more than needed; and

WHEREAS, monies appropriated to the Other Personal Services (Part-Time Officers) Account were less than needed to finish out payroll for the end of the year due to being short staffed and the Part Time Officers working additional hours to make sure the Village had 24/7 coverage; and

WHEREAS, on December 27, 2021, the Fiscal Officer transferred monies within the General Fund to cover the final payroll for 2021; and

WHEREAS, the Council of the Village of Commercial Point desires to ratify the action of the Village Fiscal Officer.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF COMMERCIAL POINT, OHIO THAT:

Section 1. Council hereby ratifies the action taken by the Village Fiscal Officer on December 27, 2021 as further set forth in Section 2 below.

Section 2. Monies in the amount of Four Hundred Fifty Dollars (\$450.00) shall hereby be transferred within the General Fund of the Village of Commercial Point from Account Number 1000-910-910 Transfers Out Account to Account Number 1000-110-190-1013 Other Personal Services (Part Time Officer) Account.

Section 3. It is hereby found and determined that all formal actions of the Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision making bodies of the Village of Commercial Point which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 4. This Resolution shall take effect and be in force from and after the earliest date allowed by law.


