

RESOLUTION 16-2022

A RESOLUTION AUTHORIZING THE VILLAGE FISCAL OFFICER TO EXPEND UP TO \$1,500.00 FOR THE PURCHASE OF FLAGS AND BANNERS FROM ACCOUNT NUMBER 2041-320-590 (PARKS AND REC - CAPITAL OUTLAY) TO BE USED IN CONNECTION WITH VILLAGE FARMERS' MARKETS AND FOOD TRUCK FESTIVALS.

WHEREAS, the legislative authority of a municipal corporation may expend public moneys for any public purpose; and

WHEREAS, the Village Council authorized a food truck festival to take place on Saturday, August 13, 2022, on certain Village-owned property via the passage of Resolution 12-2022 on March 21, 2022; and

WHEREAS, the Village Council authorized farmers' markets to take place during the summer of 2022 on certain Village-owned property via the passage of Resolution 11-2022 (as substituted) on April 4, 2022; and

WHEREAS, the Village Council desires to authorize the purchase of flags and banners to advertise the holding of said farmers' markets and food truck festival, and for future farmers' markets and food truck festivals, within the Village of Commercial Point, which the Village Council finds to be for a public purpose.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF COMMERCIAL POINT, PICKAWAY COUNTY, OHIO THAT:

Section 1. Authorization to Village Fiscal Officer to Expend up to \$1,500.00 from Account Number 2041-320-590 (Parks and Rec - Capital Outlay) for the Purchase of Flags and Banners Advertising Farmers' Markets and Food Truck Festivals in the Village. The Village Fiscal Officer is hereby authorized to expend up to one thousand five hundred dollars and 00/100 cents (\$1,500.00) for the purchase of flags and banners advertising farmers' markets and food truck festivals within the Village from Account Number 2041-320-590 (Parks and Rec - Capital Outlay).

Section 2. Declaration of Public Purpose. The Village Council hereby finds and determines that the expenditure of moneys described in Section 1 of this Resolution is for a public purpose.

Section 3. Open Meetings Certification. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council and that all deliberations of this Council and of any other committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

Section 4. Effective Date. This Resolution shall take effect and be in force from and after the earliest date allowed by law.




