

RESOLUTION 20-2022

A RESOLUTION AUTHORIZING AND DIRECTING THE MAYOR AND CHIEF OF POLICE TO DONATE THE 2009 FORD EXPLORER CURRENTLY OWNED BY THE VILLAGE OF COMMERCIAL POINT TO ANOTHER GOVERNMENTAL AGENCY OR EDUCATIONAL INSTITUTION WITH A LAW ENFORCEMENT TRAINING PROGRAM.

WHEREAS, the Village of Commercial Point is authorized to discard municipal personal property that is not needed for public use, or is obsolete or unfit for the use for which it was acquired if the Village Council determines that the municipal personal property has no value pursuant to Ohio Revised Code Section 721.15(C);

WHEREAS, the Village of Commercial Point acquired a 2009 Ford Explorer XLT (VIN 1FMEU73899UA43354) ("2009 Ford Explorer") from the Ford Motor Company, on or about May 28, 2009; and

WHEREAS, the 2009 Ford Explorer was put to use by the Village of Commercial Point Police Department for several years and for several thousands of miles; and

WHEREAS, the 2009 Ford Explorer is no longer suitable for use by the Village of Commercial Point Police Department and is no longer needed for public use; and

WHEREAS, the 2009 Ford Explorer no longer has any value; and

WHEREAS, the Village Council desires to donate the 2009 Ford Explorer to another governmental agency or educational institution with a law enforcement training program.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF COMMERCIAL POINT, PICKAWAY COUNTY, OHIO, THAT:

Section 1. Declaration that 2009 Ford Explorer is Obsolete and Not Needed for Public Use. The Village Council hereby finds that the 2009 Ford Explorer (VIN 1FMEU73899UA43354) currently owned by the Village of Commercial Point, and more fully described in the Certificate of Title attached to this Resolution as Exhibit A and incorporated herein by reference ("2009 Ford Explorer"), is not needed for public use by the Village and is obsolete for the purpose for which it was acquired.

Section 2. Declaration that 2009 Ford Explorer Has No Value. The Village Council hereby finds that the 2009 Ford Explorer has no value.

Section 3. Authorization and Direction to Donate 2009 Ford Explorer to Governmental Agency or Educational Institution with Law Enforcement Training Program. The Mayor and Chief of Police are hereby authorized and directed to take all necessary actions to effect the donation and transfer of title of the 2009 Ford Explorer to another governmental agency or educational institution with a law enforcement training program for use by said agency or educational institution.

Section 4. Open Meetings Certification. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council and that all deliberations of this Council and of any other committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

Section 5. Effective Date. This Resolution shall take effect and be in force from and after the earliest date allowed by law.




