

RESOLUTION 34-2022

**A RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY AUDITOR AND DECLARING AN EMERGENCY.**

**WHEREAS**, this Council in accordance with the provisions of law has previously adopted a Tax Budget for the next succeeding fiscal year commencing January 1<sup>st</sup>, 2023; and

**WHEREAS**, the Budget Commission of Pickaway County, Ohio has certified its action thereon to this Council together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Council, and what part thereof is without, and what part within the ten mill limitation.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF COMMERCIAL POINT, OHIO THAT:**

**Section 1.** The amounts and rates, as determined by the Budget Commission in its certification, be and the same are hereby accepted.

**Section 2.** There be and is hereby levied on the tax duplicate of said Village the rate of each tax necessary to be levied within and without the ten-mill limitation as shown in Exhibit A.

**Section 3.** The Village Fiscal Officer is hereby directed to certify a copy of this Resolution to the County Auditor of Pickaway County.

**Section 4.** This Resolution is deemed to be an emergency because the Resolution must be certified to the County Auditor no later than October 1, 2022, and shall, therefore, go into effect immediately upon passage for the preservation of the public peace, health, or safety.
