

VILLAGE OF COMMERCIAL POINT Special Council Meeting Minutes October 25th, 2021

Mayor Goldhardt called the meeting to order at 6:30 pm. Administrative Assistant Baldwin took roll call with the following members present: Ms. Wolfe, Mr. Mitchem, Ms. Joiner, Mr. Thompson, Ms. Geiger and Mr. Grassel.

A motion was made to suspend the procedural rules by Mr. Thompson and seconded by Ms. Joiner. All were in favor. The motion passed.

Legislation:

First Reading:

Ordinance 2021-41 AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR AND VILLAGE ADMINISTRATOR TO ENTER INTO A FIRST AMENDMENT TO DEVELOPMENT AGREEMENT WITH COI RICKENBACKER INDUSTRIAL LAND, LLC, AND DECLARING AN EMERGENCY.

Mayor Goldhardt did a first reading, title only.

Mayor Goldhardt explained to Council that Van Trust has offered to pay the Village a \$50,000 settlement for manhole #1. In exchange for the settlement monies, the Village will exchange their Performance Bond for a Maintenance Bond. The Maintenance Bond will not cover manhole #1 or any future issues with that manhole. Ms. Joiner asked if it is enough money. Mayor Goldhardt said that the Village will assume some financial responsibility. Solicitor Cartee said he would encourage waiving the three readings and for Council to approve the ordinance, otherwise it could interfere with timelines.
